1. Background

This report covers the joint control operations that were carried out as from the 5th of January 2015 until the 30th of June 2015 in the framework of the northern North Sea (NNS) joint campaign.

2. General objective

To ensure compliance with the requirements of Commission Implementing Decision 2013/328/EU, the cod recovery measures as specified in Council Regulation (EC) No 1342/2008, and the management measures for sole and plaice as specified in Council Regulation (EC) No 676/2007, by means of a coordinated programme of inspections of fishing vessels, at sea and at the ports of landing.

3. Specific objectives

Specific objectives were adopted by the NS Steering Group and prioritised by the NNS Technical Joint Deployment Group and included:

- a) to inspect vessels and/or catches coming from vessels likely to catch cod which have been identified by risk analysis as liable to be in contravention of fishery conservation measures,
- b) control of fishing activities by fishing vessels subject to effort limitations and likely to catch cod as a by-catch,

c) to carry out inspections to identify real-time closure areas and to monitor the compliance with real-time closure areas.

4. Summary of activity

a) Inspections ashore

During this joint campaign reporting period 7.304 tonnes of cod, plaice and sole were inspected at landing. In total, there were 2245 inspections carried out ashore with 26 suspected infringements reported.

b) Inspections at sea

During this joint campaign reporting period 642 tonnes of cod, plaice and sole were monitored at sea. In total, there were 209 inspections carried out at sea with 14 suspected infringements reported.
