1. Background

This report covers the joint control operations that were carried out as from the 5th of January 2015 until the 31st of March 2015 in the framework of the southern North Sea (SNS) joint campaign.

2. General objective

To ensure compliance with the requirements of Commission Implementing Decision 2013/328/EU, the cod recovery measures as specified in Council Regulation (EC) No 1342/2008, and the management measures for sole and plaice as specified in Council Regulation (EC) No 676/2007, by means of a coordinated programme of inspections of fishing vessels, at sea and at the ports of landing.

3. Specific objectives

Specific objectives were adopted by the NS Steering Group and prioritised by the SNS Technical Joint Deployment Group and included:

- a) to inspect vessels and/or catches coming from vessels likely to catch cod which have been identified by risk analysis as liable to be in contravention of fishery conservation measures,
- to promote, monitor and evaluate the compliance with the requirements of the landing obligations and the accurate recording of discards in logbooks by masters of fishing vessels,
- c) to carry out inspections to identify real-time closure areas and to monitor the compliance with real-time closure areas.

4. Summary of activity

a) Inspections ashore

During this joint campaign period 1063 tonnes of demersal species were inspected at landing. In total, there were 129 inspections carried out ashore with 10 suspected infringements reported.

b) Inspections at sea

During this joint campaign period 2349 tonnes of demersal species were monitored at sea. In total, there were 190 inspections carried out at sea with 30 suspected infringements reported.
