Having regard to Council Regulation (EC) No 768/2005 of 26 April 2005¹ establishing a European Fisheries Control Agency (hereinafter referred to as 'EFCA'), and in particular Articles 17f, 23(2)(c) and 23(2)(d) thereof,

Having regard to AB Decision No 13-W-09 of 31 December 2013 concerning the Financial Regulation of the European Fisheries Control Agency, and in particular Article 38 thereof,

Whereas:

- (1) Due to the service needs of EFCA for highly qualified operational staff, capable of coordinating missions with MS experts at sea and ashore, but also with the ability to assist the entire process of JDPs from planning, implementation and evaluation, one AST grade 10 post in the 2019 establishment plan should be modified into an AD grade 7 post under the flexibility rule.
- (2) AB Decision No 18-II-4 of 10 October 2018 concerning the adoption of the EFCA Programming Document (PD) containing the Multiannual work programme 2019-2020 and the Annual work programme for year 2019 and of the Budget and the Establishment Plan of the European Fisheries Control Agency for year 2019 therefore needs to be amended,

HAS DECIDED AS FOLLOWS:

Article 1

The establishment plan table for 2019 in Annex II to AB Decision No 18-II-4 is replaced by the table in the Annex to this decision.

Article 2

This decision shall take effect on 1 May 2019.
