### **DECISION No 20-W-2**

## OF THE ADMINISTRATIVE BOARD

## OF THE EUROPEAN FISHERIES CONTROL AGENCY

#### of 22.04.2020

amending AB Decision No 19-II-4 of 22 October 2019 concerning the adoption of the EFCA Single Programming Document containing the Multiannual work programme 2020 - 2024 and the Annual work programme for year 2020 and of the Budget and the Establishment Plan of the European Fisheries Control Agency for year 2020 THE ADMINISTRATIVE BOARD OF THE EUROPEAN FISHERIES CONTROL AGENCY

Having regard to Regulation (EU) 2019/473 of the European Parliament and of the Council of 19 March 2019 on the European Fisheries Control Agency<sup>1</sup> (hereinafter referred to as "EFCA"), and in particular Articles 24, 32(2)(c) and 32(2)(d) thereof,

Having regard to AB Decision No 19-W-5 of 29 August 2019 concerning the Financial Regulation of the European Fisheries Control Agency, and in particular Articles 32 and 33 thereof,

#### Whereas:

- (1) Following EFCA's role in the international dimension of the Common Fisheries Policy, it is necessary to include activities to explore new possible projects in the international dimension, that can permit to extend the EU control best practices and cooperation with Third Countries.
- (2) AB Decision No 19-II-4 of 22 October 2019 concerning the adoption of the EFCA Single Programming Document containing the Multiannual work programme 2020 - 2024 and the Annual work programme for year 2020 and of the Budget and the Establishment Plan of the European Fisheries Control Agency for year 2020 therefore needs to be amended,

HAS DECIDED AS FOLLOWS:

#### Article 1

AB Decision No 19-II-4 is amended as follows:

1. In Annex I, in Point 2.1.1. Overview of the Activity of Section 2.1. Joint Deployment Plans, Operational Plans and Pilot Projects (Objectives 1-2), the second last bullet point in the description of the implementation of the JDPs, operational plan and pilot projects is replaced by the following:

"-The deployment of control means, cooperation and exchange of information between the competent authorities, including with third countries in the framework of the GFCM pilot projects and of future arrangements with Northern Coastal States;"

 In Annex I, in Point 2.3.2. Objectives, indicators, expected outcomes and outputs of Section 2.3. International dimension: compliance with international provisions (Objectives 4-5), the fiche of Objective 5 is replaced by the following:

## **OBJECTIVE 5**

To strengthen compliance through the implementation of EU international projects as regards fisheries monitoring, control and surveillance

#### EXPECTED RESULTS

- 1. Strengthening of prevention and responses to IUU fishing in the areas concerned
- 2. Harmonisation of third countries legal framework in accordance with international standards,
- 3. Increased capacity of third countries fisheries inspectors and other officials.
