

DECISION NO 08-I-13(2)

OF THE ADMINISTRATIVE BOARD

OF THE COMMUNITY FISHERIES CONTROL AGENCY

of 13 March 2008

concerning an amendment to the Decision of the Administrative Board of CFCA of 27 September 2006 concerning the arrangements to be applied by the Agency for Public Access to documents

THE ADMINISTRATIVE BOARD OF THE COMMUNITY FISHERIES CONTROL AGENCY

Having regard to Council Regulation (EC) No 768/2005 of 26 April 2005 establishing a Community Fisheries Control Agency¹, and in particular Article 32(2) thereof,

Whereas:

- (1) It is necessary to clarify the provisions of Regulation (EC) No 1049/2001 of the European Parliament and of the Council of 30 May 2001 regarding public access to European Parliament, Council and Commission documents² in relation to the classification of documents and the annual report.
- (2) It is necessary to update the Annex to the Arrangements to be applied by the Community Fisheries Control Agency (CFCA) for Public Access to documents adopted by the Administrative Board on 27 September 2006.
- (3) The aforementioned Arrangements to be applied by the CFCA for Public Access to documents should therefore be amended accordingly.

Article 1

1. The following Articles shall be inserted in the Decision of the Administrative Board concerning the arrangements to be applied by the CFCA for Public Access to documents:

"Article 2a - Classification of documents

The CFCA's documents shall be classified in one of the following categories: public, EU restricted, EU confidential, in accordance with Commission Decision (2001/844/EC, ECSC, Euratom) of 29 November 2001 amending its internal Rules of Procedure³.

Article 9a – Report

The Administrative Board, acting on a proposal from the Executive Director, shall publish annually, as part of the annual report, information concerning the implementation of this decision, in particular statistics on the number of requests for access to CFCA documents, the number of refusals, the reasons for such refusals and the number of sensitive documents within the meaning of Article 9 of Regulation (EC) No 1049/2001 not recorded in the register."

2. The address details for application for access to documents in the Annex to the Arrangements to be applied by the CFCA for Public Access to documents shall be replaced by the following:
