THE ADMINISTRATIVE BOARD OF THE EUROPEAN FISHERIES CONTROL AGENCY

Having regard to Regulation (EC) No 768/2005 of 26 April 2005¹ establishing a European Fisheries Control Agency (hereinafter referred to as 'EFCA'), and in particular Article 23(2)(c) thereof,

Whereas:

- (1) EFCA was informed by the European Commission that the Project "Improved Regional Fisheries Governance in Western Africa" (PESCAO) has been adopted by Decision C (2017) 2951 on 28 April 2017.
- (2) A part of this Project may be implemented in indirect management by EFCA. This implementation entails providing technical assistance to Regional Fisheries Bodies (Subregional Fisheries Commission (SRFC) and Fisheries Committee for the Western Central Gulf of Guinea (FCWC)) and their member countries in order to improve regional cooperation in the fight against IUU fishing.
- (3) A grant up to 2,585,000 EUR will be awarded to EFCA in order to implement this project in an indicative period of 5 years. EFCA is an authority entrusted by the European Commission and is able to receive ad-hoc grants for capacity building, monitoring, control and surveillance activities in third countries.
- (4) The indicative time to conclude the grant agreement with the European Commission is the second semester of 2017. Notwithstanding, the European Commission authorises that the costs incurred by the EFCA may be recognised as eligible as of the adoption of the Project decision, as EFCA will support EU delegations in the preparation of the grant contracts with SRFC and FCWC.
- (5) It is needed to include in the relevant part of the Annual work programme for 2017 the activities of support and preparation of the grant agreement of EFCA and also the support to the EU Delegations to prepare the grant contracts with SRFC and FCWC.
- (6) The Administrative Board adopted at its 26th meeting held on 11 October 2016 the EFCA Single Programming Document (SPD) containing the Multiannual work programme 2017-2021 and the Annual work programme for year 2017.
- (7) The Multiannual work programme 2017-2021 and the Annual work programme for year 2017 should therefore be amended,

Article 1

Annex I to the Decision of the Administrative Board No 16-III-05 concerning the EFCA Single Programming Document (SPD) containing the Multiannual work programme 2017-2021 and the Annual work programme for year 2017 is amended as follows:

1. In the Section III, Annual work programme year 2017, point 2.3.2 Objectives, indicators, expected results and outputs, the Objective 9 fiche shall be replaced by the following:

Objective 9

Provision of training activities and Sectoral Qualification Framework in support of the effective and uniform application of the CFP, including fisheries control expertise in the context of the EUCG functions and preparation of the programme PESCAO
