2. **General objective**

To ensure the implementation of the Black Sea JDP 2022, by means of a coordinated programme of surveillance and control operations at sea and ashore, regarding the fishing activities and fishing related activities directed to species listed according to Annex II of the implementing Decision (EU) 2018/1986.

3. **Summary of activity**

This report is a statistical snapshot of JDP activity between January and December 2022 (quarters 1+2+3+4).

In total, there were 117 (109 fishing vessels and 8 other fishing gears or objects) inspections carried out at sea with 3 suspected infringements reported, and 1358 land inspections carried out with 10 suspected infringements reported in 9 inspections. In addition, there are 239 sightings reported from both Member States and Frontex.
