2. General objective

To ensure the implementation of the Eastern Atlantic and Mediterranean JDP 2021, by means of a coordinated programme of surveillance and control operations at sea and ashore, regarding the fishing activities and fishing related activities directed to species listed according to Annex I of the implementing Decision (EU) 2018/1986.

3. Summary of activity

This report is a statistical snapshot of JDP activity between January and December (quarters 1+2+3+4).

In total, there were 778 inspections with apparent infringements reported out of 12350 inspections carried out at sea, 2722 inspections with apparent infringements reported out of 28486 inspections carried out ashore, and 5643 sightings from which 274 of them were reported with apparent infringements.
