2. *General objective*

To ensure the implementation of the Eastern Atlantic and Mediterranean JDP 2022, by means of a coordinated programme of surveillance and control operations at sea and ashore, regarding the fishing activities and fishing related activities directed to species listed according to Annex I of the implementing Decision (EU) 2018/1986.

3. *Summary of activity*

This report is a statistical snapshot of JDP activity between January and December (Quarter 1+2+3+4).

In total, there were 620 inspections with apparent infringements reported out of 10644 inspections carried out at sea, 3015 inspections with apparent infringements reported out of 25695 inspections carried out ashore, and 4869 sightings from which 258 were reported with apparent infringements.
