2. **General objective**

To ensure operational coordination of joint control, inspection and surveillance activities by the Member States concerned by the JDP, facilitated by the EFCA in order to fulfil the obligations of the European Union under the NAFO Convention.

3. **Summary**

This report covers the joint campaign activities in the NAFO RA. The report provides statistical information registered by the European Fisheries Control Agency (EFCA) concerning the joint control activities that were carried out by air, sea and shore-based assets and teams of the participating Member States (MS) from the NAFO JDP.

The numbers shown in this report have been extracted from the EFCA database according to the activity submitted by the MS within the context of the NAFO JDP. Only those data that meet certain quality criteria are recorded in the EFCA database. These data are provisional and are kept under continuous review. The extraction of data was done on 9th October 2023, for the NAFO related events, patrols, and targets.

a) Inspections ashore

During the reporting period there were 36 inspections carried out ashore. The inspection teams reported in total 7 suspected (apparent) infringements related to 1 fishing vessel.

b) Inspections at sea

During the reporting period there were 46 inspections carried out at sea. The inspection teams reported 5 suspected (apparent) infringement related to 5 vessels.

c) Surveillance

In total, were reported 30 sightings from patrol vessels with no suspected (apparent) infringements detected.
