#### 2. General objective

To ensure operational coordination of joint control, inspection and surveillance activities by the Member States concerned by the JDP, facilitated by the EFCA in order to fulfil the obligations of the European Union under the NAFO Convention.

## 3. Summary

This report covers the joint campaign activities in the NEAFC RA. The report provides statistical information registered by the European Fisheries Control Agency (EFCA) concerning the joint control activities that were carried out by air, sea and shore-based assets and teams of the participating Member States (MS) from the NEAFC JDP.

The numbers shown in this report have been extracted from the EFCA database according to the activity submitted by the MS within the context of the NEAFC JDP. Only those data that meet certain quality criteria are recorded in the EFCA database. These data are provisional and are kept under continuous review. The extraction of data was done on 15<sup>th</sup> January 2024, for the NEAFC related events, patrols, and targets.

#### a) Inspections at sea

During the reporting period there were 23 inspections carried out at sea with 2 suspected (apparent) infringements reported related to 1 fishing vessel.

#### b) Surveillance

In total, were reported 85 sightings from patrol vessels with no suspected (apparent) infringements detected and 34 air sightings with no suspected (apparent) infringements detected during the surveillance carried out in this period.
