### 1. **Background**

This report is a statistical summary of the joint control operations that were carried out from the 2<sup>nd</sup> of January until the 31<sup>st</sup> of March 2017 in the operational area of the North Sea joint campaign.

### 2. **Objectives**

The general objective is to ensure compliance with the requirements of Commission Implementing Decision 2013/328/EU, Commission Delegated Regulation (EU) 2015/2438 and Commission Delegated Regulation (EU) 2015/2440, by means of a coordinated programme of inspections of fishing vessels at sea and in ports of landing.

### 3. Summary of activity

#### a) Inspections ashore

During this joint campaign reporting period 5682 tonnes of cod, plaice and sole were inspected at landing. In total, there were 2066 inspections carried out ashore, including 1379 market inspections, with a total of 37 suspected infringements reported.

#### b) Inspections at sea

During this joint campaign reporting period 696 tonnes of cod, plaice and sole were monitored at sea. In total, there were 294 inspections carried out at sea with 38 suspected infringements reported on 35 fishing vessels.
