### 1. Objectives

To ensure uniform and effective implementation of conservation and control measures applicable to pelagic fisheries in Western Waters (WW) as specified in Commission Decision 2012/807/EU, by means of a coordinated programme of inspections of fishing vessels, at sea and at the ports of landing, and throughout the whole chain including processing, transport and trade.

### 2. Summary of activity

This report provides summary information concerning the joint control activities that were carried out by air, sea and shore based assets and inspection teams of the participating Member States from 2<sup>nd</sup> of January until 30<sup>th</sup> of September, 2017.

#### a) Inspections ashore

During this joint campaign reporting period 367,312 tonnes of pelagic catches were inspected at landing. In total, there were 541 inspections carried out ashore and reported 4 suspected infringements were detected.
