1. Objectives

To ensure uniform and effective implementation of conservation and control measures applicable to pelagic fisheries in Western Waters (WW) as specified in Commission Decision 2012/807/EU, by means of a coordinated programme of inspections of fishing vessels, at sea and at the ports of landing, and throughout the whole chain including processing, transport and trade.

2. Summary of activity

This report is a statistical snapshot all the JDP activities between January and March.

Around 2,808 tonnes of catches of JDP pelagic species were monitored at landing. In total, there were 37 infringements reported out of 441 inspections carried out at landing, transport and market inspections. The breakdown by species as follows:
