2. General objective

To ensure compliance with the requirements of Commission Implementing Decision (EU) 2018/1986, Commission Delegated Regulation (EU) No 1393/2014, Commission Delegated Regulation (EU) No 1394/2014, Commission Delegated Regulation (EU) No 2018/2033 and Commission Delegated Regulation (EU) No 2018/2034, by means of a coordinated programme of inspections of fishing vessels at sea and in ports of landing.

3. Summary

This report is covering the joint campaign activities in the Western Waters JDP operational area for demersal species and for pelagic species. The report provides overall summary information concerning the joint control activities that were carried out by air, sea and shore based assets and teams of the participating Member States from 1st January to 31th March, 2019.

a) Inspections ashore

During this reporting period there were 679 inspections carried out ashore, including 8 transport inspections. The inspection teams reported in total 13 suspected infringements detected.
