



PRIVACY STATEMENT IN THE CONTEXT OF PROCESSING OF PERSONAL DATA OF THE CCTV VIDEOSURVEILLANCE SYSTEM

WHY AND HOW DO WE PROCESS YOUR DATA?	The European Fisheries Control Agency is committed to respect the right to data protection and it is subject to Regulation (EU) 2018/1725 ¹ . The purpose of this data processing is to get security and access control to the EFCA headquarter located in "Edificio Odriozola" Garcia Barbon 4. The video-surveillance system helps control access to EFCA building and helps ensure EFCA's security, the safety of EFCA staff and visitors, as well as property and information located or stored on the premises. It complements other physical security systems such as access control systems and physical intrusion control systems.

LEGAL GROUND/S	This activity is carried out by the Agency based on public interest. ART. 38(3)(B) REGULATION (EU) 2019/473 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 19 March 2019 on the European Fisheries Control Agency. EFCA's video-surveillance system is used for typical security and normal access control purposes and is necessary for the management and functioning of the Agency (Article 5(a) and Article 5.1(a) of the EUDPR Regulation 2018/1725 and is so based on a lawful ground, as required.
WHAT DATA WE COLLECT?	Live and recorded images
WHO HAS ACCESS TO YOUR DATA?	Security guards, EFCA Local Security Officer and EFCA Security coordinators.
HOW DO WE PROTECT YOUR PERSONAL INFORMATION?	A number of technical and organisational measures have been put in place by the Agency. Technical measures include appropriate actions to address online security, risk of data loss, alteration of data or unauthorised access according to the <u>EFCA Information Security Policy</u> . Organisational measures include restricting access to the personal data solely to authorised persons with a legitimate need to know for the purposes of this processing operation.
HOW LONG DO WE KEEP YOUR DATA?	7 days
YOUR RIGHTS AS DATA SUBJECT	You have the right to access all your personal data, including the supporting documents, and may request them to be updated and rectified, blocked or erased.
