## 2. General objective

To ensure uniform and effective implementation of conservation and control measures applicable to pelagic fisheries in Western Waters (WW) as specified in Commission Decision 2012/807/EU, by means of a coordinated programme of inspections of fishing vessels, at sea and at the ports of landing, and throughout the whole chain including processing, transport and trade.

## 3. Summary of activity

This report is a statistical snapshot of JDP activity between January and September (quarters 1 to 3).

Around 201,478 tonnes of catches of JDP pelagic species were monitored at landing. The breakdown by species as follows:

In total, there were 2 infringements reported out of 402 inspections carried out at landing.

Around 23,404 tonnes of catches of JDP pelagic species were inspected at sea. The breakdown by species is as follows:
