<p>WHY AND HOW DO WE PROCESS YOUR DATA?</p>	<p>The European Fisheries Control Agency is committed to respect the right to data protection and it is subject to Regulation (EU) 2018/1725¹. The Agency collects personal data with the purpose to Comply with the project 'Implementation of the results of the Coast Guard qualifications Network and the Practical Handbook on European cooperation on coast guard functions' (Contribution Agreement SI2.859465), which supports the cooperation with and between the competent European coast guard function authorities.</p> <p>According to the Commission Recommendation of 20.7.2021 establishing a 'Practical Handbook' on European cooperation on coast guard functions (and its Annex), the Practical Handbook and the Coast Guard Capacity Building and Training Network will be hosted on an online platform (the Portal), which will be used by the Member States (and EFTA States) national authorities implementing coast guard functions. Contact Information of the training network and the exchange programme participants will also be managed.</p> <p>Additional purposes of the processing of personal data are: Management of European cooperation on coast guard project related meetings and of the training network and exchange programme participants, including management of: lists of contacts, invitations, contact information of participants, reimbursement of participants, reports, distribution of reports/minutes, feedback on reports, meeting follow-up, follow-up meetings, follow-up actions, information sharing, sharing of contact lists among participants. Appearing in photos and videos communicating about the meeting internally and for publicity purposes, such as printed and online publicity, social media and press releases.</p>

<p>WHO HAS ACCESS TO YOUR DATA?</p>	<p>Designated EFCA staff.</p> <p>Designated representatives of Member States authorities, as well as the designated representatives authorities of Norway and Iceland implementing coast guard functions, or of authorities, entities and Academies dealing with capacity building and training.</p> <p>Exchange programme participants.</p> <p>Designated EMSA and Frontex staff cooperating with EFCA in the project.</p> <p>Contractors will only have access to the extent necessary for the building up and maintenance of the ECGF online platform.</p>
<p>HOW DO WE PROTECT YOUR PERSONAL INFORMATION?</p>	<p>A number of technical and organisational measures have been put in place by the Agency. Technical measures include appropriate actions to address online security, risk of data loss, alteration of data or unauthorised access according to the EFCA Information Security Policy. Organisational measures include restricting access to the personal data solely to authorised persons with a legitimate need to know for the purposes of this processing operation.</p>
<p>HOW LONG DO WE KEEP YOUR DATA?</p>	<p>The entire duration of the project: 60 months from 1 February 2022</p>
