WHY AND HOW DO WE PROCESS YOUR DATA?	The purpose of this data processing related to the e-FishMed Project is to support the effective implementation of conservation and management measures through enhanced capacities, knowledge, skills and competences in fisheries control and inspection and the fight against IUU fishing. The Specific Objective is to improve national and regional MCS systems of Beneficiary Countries by setting-up a virtual regional training academy. The eFishMed project beneficiary countries (namely Algeria, Libya, Mauritania, Morocco and Tunisia).

	This activity is carried out by the Agency based on public interest. According to Article 4.1 of Regulation (EU) 2019/473, the tasks of EFCA relating to the international obligations of the Union relating to control and inspection are: (a) assist the Union and the Member states in their relations with third countries and regional international fisheries organisations of which the Union is a member; (b) cooperate with the competent authorities of regional international fisheries organisations regarding the control and inspection obligations of the Union in the framework of working arrangements concluded with such bodies. To properly carry out the task of providing assistance to Member States, the Commission and upon request to third countries – here in form of capacity building and training material.
LEGAL GROUND/S	The e-FishMed project (Mediterranean virtual regional training academy on fisheries control and inspection) is financed under the European Maritime, Fisheries and Aquaculture Fund (EMFAF). The Implementing Decision – $C(2021)$ 3870 final - was adopted on 4.06.2021 and the action is included in the EMFAF work programme 2021 under Priority 4 – Strengthening international ocean governance and enabling safe, secure, clean and sustainably managed seas and oceans.
	The project was also included in the EFCA Single Programming Document (SPD) 2022-2026 and it is mentioned under objective 3 point 4 (page 18), under point 1.2 Grants (page 21). It was also included in the EFCA Annual Work Programme 2022 under point 2.3 International Dimension (pages 36 and 37) and in Annex 11 (page 88). The project it is now included in the EFCA Single Programming Document (SPD) 2023-2027 and it is mentioned under objective 3 point 5 (page 18)), under point 1.2 Grants (page 21). It is also included in the EFCA Annual Work Programme 2023 under point 2.3 International Dimension (page 36 and 38) and in Annex 11 (page 86).
WHAT DATA WE COLLECT?	Name and surname, contact and professional details of Fisheries inspectors and officials in charge of fisheries control, from Algeria, Libya, Mauritania, Morocco and Tunisia and EU Member states Private experts and other collaborators in exceptional cases.
WHO HAS ACCESS TO YOUR DATA?	Designated EFCA staff / Designated Staff EU bodies.
HOW DO WE PROTECT YOUR PERSONAL INFORMATION?	A number of technical and organisational measures have been put in place by the Agency. Technical measures include appropriate actions to address online security, risk of data loss, alteration of data or unauthorised access according to the <u>EFCA Information Security Policy</u> . Organisational measures include restricting access to the personal data solely to authorised persons with a legitimate need to know for the purposes of this processing operation.
