2. Background

This report is giving an overview of the joint campaign activities (JDP-NS-2014-03) in the JDP operational area of the Irish Sea and waters southern west of Scotland. The report provides summary information concerning the joint control activities that were carried out as from the 6th January 2014 until 19th December 2014.

3. General objectives

To ensure compliance with the requirements of Commission Implementing Decision 2013/328/EU, the cod recovery measures as specified in Council Regulation (EC) No 1342/2008, by means of a coordinated programme of inspections of fishing vessels, at sea and at the ports of landing.

4. Specific objectives

Specific objectives were adopted by the North Sea Steering Group and prioritised by the Technical Joint Deployment Group and included:

- a) to inspect vessels and/or catches coming from vessels likely to catch cod which have been identified by risk analysis as liable to be in contravention of fishery conservation measures,
- b) control of fishing activities by fishing vessels subject to effort limitations and likely to catch cod as a by-catch.

5. Summary

a) Inspection ashore

During this joint campaign period 431 tonnes of demersal species were inspected at landing. In total, there were 396 inspections carried out ashore with 2 suspected infringements reported.

a) Inspections at sea

During this joint campaign period around 41 tonnes of demersal species were monitored at sea. In total, there were 33 inspections carried out at sea with 3 suspected infringements reported.
