2. Background

This report is a statistical snapshot of the joint campaign activities (JDP-NS-2014-01) in the Kattegat, Skagerrak, Waters West of Scotland, Central and Northern North Sea JDP operational area. The report provides summary information concerning the joint control activities that were carried out as from the 6th of January 2014 until the 31st of March 2014.

3. General objective

The general objective of the campaign was to ensure compliance with the cod recovery measures as specified in Council Regulation (EC) No 1342/2008 and Commission Decision 2013/328/EC, by means of a coordinated programme of inspections of fishing vessels, at sea and in the ports of landing.

4. Specific objectives

Specific objectives were determined and prioritised by the Technical Joint Deployment Group (TJDG) and included:

- a) To inspect vessels and/or catches coming from vessels likely to catch cod, plaice or sole, which have been identified by risk analysis as liable to be in contravention of fishery conservation measures, in particular in the following manner:

b) Control of fishing activities by fishing vessels subject to effort limitations and likely to catch cod as a by-catch,

c) To carry out inspections to identify real-time closure areas and to monitor the compliance with the same real-time closure areas.

5. Summary of activities

a) Inspections ashore

During this joint campaign period 2530 tonnes of demersal species were inspected at landing. In total, there were 772 inspections carried out ashore with 14 suspected infringements reported.
