#### 2. General objective

To ensure the implementation of the Eastern Atlantic and Mediterranean JDP 2020, by means of a coordinated programme of inspections at sea and on land, regarding the fishing activities and fishing related activities directed to species listed according to Annex I of the implementing Decision (EU) 2018/1986

### 3. Summary of activity

This report is a statistical snapshot of JDP activity between January and September (quarters 1+2+3).

In total, there were 312 inspections with apparent infringements reported out of 6847 inspections carried out at sea, 652 inspections with apparent infringements reported out of 10852 inspections carried out ashore, and 2330 sightings from which 51 of them were reported with apparent infringements.
