
### 2. General objective

To ensure the implementation of the Black Sea JDP 2022, by means of a coordinated programme of surveillance and control operations at sea and ashore, regarding the fishing activities and fishing related activities directed to species listed according to Annex II of the implementing Decision (EU) 2018/1986.

## 3. Summary of activity

This report is a statistical snapshot of JDP activity between January and March 2022 (quarter 1).

In total, there were 24 inspections carried out at sea without any infringement reported, and 322 land inspections carried out with 2 apparent infringements reported in 2 inspections.
