2. **General objective**

To ensure the implementation of the Black Sea JDP 2021, by means of a coordinated programme of surveillance and control operations at sea and ashore, regarding the fishing activities and fishing related activities directed to species listed according to Annex II of the implementing Decision (EU) 2018/1986.

3. **Summary of activity**

This report is a statistical snapshot of JDP activity between January and December 2021 (Quarter 4).

In total, there were 136 inspections carried out at sea with 6 apparent infringements reported in 6 inspections, and 1752 inspections carried out at landing with 33 apparent infringements reported in 23 inspections.
