## 2. General objective

To ensure uniform and effective implementation of conservation and control measures applicable to pelagic fisheries in Western Waters (WW) as specified in Commission Decision 2012/807/EU, by means of a coordinated programme of inspections of fishing vessels, at sea and at the ports of landing, and throughout the whole chain including processing, transport and trade.

## 3. Summary of activity

This report gathers all the JDP activity between January and June (quarters 1 and 2).

Around 195,604 tonnes of catches of JDP pelagic species were monitored at landing. The breakdown by species as follows:

In total, there were 4 infringements reported out of 369 inspections carried out at landing.

Around 43,565 tonnes of catches of JDP pelagic species were inspected at sea. The breakdown by species is as follows:
